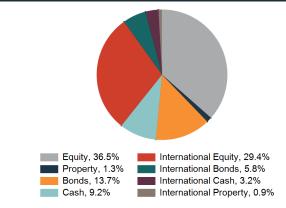

## **Asset Allocation**



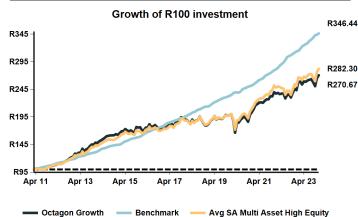

<sup>\*</sup> The Octagon SCI Growth FoF was launched on 21 January 2016 and transitioned into the Octagon Moderate Aggressive wrap fund over a number of weeks to manage market volatility and cash flows more effectively with the underlying managers. The transition was completed during April 2016 and hence from May 2016 onwards performance of the Octagon Moderate Aggressive wrap will reflect that of the Octagon SCI Growth FoF. Important to note that the fund mandate remains unchanged and continues to be managed and in accordance with the SA Multi Asset High Equity mandate (limited to a maximum of 75% in equity and 25% offshore) by the same Octagon investment committee. Subsequently the Octagon Moderate Aggressive wrap fund was renamed to the Octagon Growth wrap.
